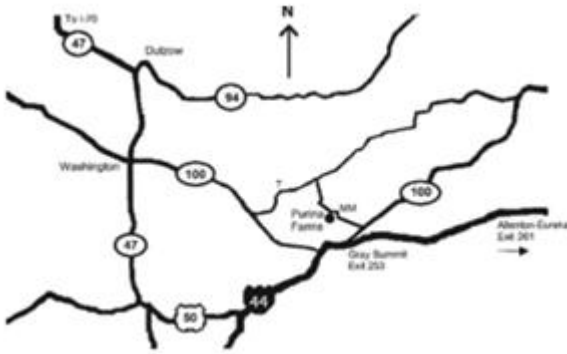
DOGS ELIGIBLE TO ENTER

These events are open to Cane Corso which have been registered with the American Kennel Club and are six (6) months of age or older or have an acceptable foreign registration number (subject to restrictions in Chapter 11, Section 1 of the Rules Applying to Dog Shows). Obedience and Rally classes are open to dogs of all breeds which are six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or are approved Foundation Stock Service (FSS) breeds. Bitches in season may not compete in Obedience or Rally. The Cane Corso Association of America will NOT be accepting Obedience or Rally entries for dogs listed in the AKC Canine Partners Program, which includes All American/ Mixed Breed dogs.

TRANSFERS

A transfer request from one Obedience or Rally class to another will be accepted prior to and after the trial closing date. Such requests should be sent through regular mail or email or presented to the Trial Secretary at least 30 minutes prior to the start of the trial, and should include the following information: Owner's name, dog's registered name, dog's registration #, jump height (if any), class moving from and class moving to.
